

## Grand View Memorial Park – Lawsuits’ Update

Several lawsuits have been filed against the Cemetery and its owners. Although the City of Glendale is not a party in those lawsuits, the City is monitoring the lawsuits and the court proceedings. The two most noteworthy lawsuits are described below. The City cannot predict when these lawsuits will end or their outcome. Occasionally the City will update this information when significant events occur.

### MARY LOUISE LARGEY, et al. (Plaintiffs) vs. GRAND VIEW MEMORIAL PARK, INC., et al. (Defendants)

Lawsuit Description: Family members whose relatives are buried at the Cemetery are suing the Cemetery and its owners for monetary damages and other relief.

Significant Developments:

Judge Mohr issued an “*evidence preservation order*,” requiring that all records, documents, buildings, vehicles, and tangible things within the Cemetery must be preserved and must not be removed from the Cemetery until further order of the Court. Although Judge Mohr’s order requires that nothing in the Cemetery can be disturbed or taken, the order allows visitors at the Cemetery to clean a grave marker, hand trim dried grass, and leave commemorative items (i.e., cut flowers, photograph, toy) at a grave site.
